

TERMS AND CONDITIONS

1. This competition is open only to residents of South Africa aged 18 years or over. Proof of age, identity and eligibility may be requested.
2. You are not eligible to enter and will be disqualified if:
 - 2.1. You are or ever have been a food professional, such as a chef, food writer, culinary specialist or educator, or someone who creates recipes for pay (including but not limited to the sale of food products made from your original recipes).
 - 2.2. You have been a finalist in three or more Sunday Times Goodlife Gautrain Experience Competitions, or have previously been a Sunday Times Goodlife Gautrain Experience Grand Prize Winner.

 - 6.1. Any specific dish or utensil or baking equipment to bake or cook with, this is the responsibility of the contestant to bring with them. The Pick n Pay Good Food Studio will provide standard dishes, or utensil, or baking or kitchen equipment.
7. Only one entry per person will be accepted. Entry is free and no purchase is necessary
